### Attention Campers!!!

# Here are the restrictions for camping at Poor Farmer's \* Any person(s) not adhering to these guidelines will be asked to leave the property.

- If you are sick or have a fever, you need to stay home.
- All persons on the grounds must keep within the guidelines of social distancing.
- Keep a minimum of 6ft between you and the next person.
- Keep your hands washed and hand sanitizer available and ready.
- Visitors <u>are not</u> permitted at your campsite.
- No gathering in groups 10 or more.
- No more than (2) persons permitted in the restroom at one time.
- The playground is closed.
- No customers are permitted into any buildings (Parts Store, Camp Office, All Shelters and Admin Offices) at Poor Farmer's. The Parts, Service and Sales will be conducting business using the front window at the Parts Store.
- There must be a minimum distance of 20 ft between campers.
- "Circling the Wagons" will not be permitted.
- Parents are responsible for your minor children. Please make sure that the kids are following these social distancing guidelines.

Thank you for your understanding of the situation we are in. Poor Farmer's RV is keeping the health and safety of our customers and employees at the top of our list. If you see any behavior that does not follow these guidelines, please let us know. We will strive to make Poor Farmer's Campground a safe and relaxing haven for you and your family.
